

107TH Amateur Championship Qualifying Huntsville Golf Club June 17, 2020



NOTICE TO PLAYERS

THE RULES OF THE UNITED STATES GOLF ASSOCIATION GOVERN PLAY: Complete text of Rules and Local Rules may be found in the Official Guide to the Rules of Golf, effective January 2019. This information also supplements the 2020 PAGA Local Rules (Hard Card) and the PAGA Covid-19 Procedures.

FORMAT: 18-Holes Individual Stroke Play. The top ten (10) scores and ties will advance to the Amateur Championship. All play is from the **White PAGA Tee Marks**.

AUTOMOTIVE TRANSPORTATION: Single rider carts are required for the stipulated round and included with entry fee.

CADDIES: Not permitted.

SCORECARDS: Physical scorecards will not be issued and groups will be given a GGID for scoring on the Golf Genius app on the starting tee. Players should verify their scores at the scoring area at the completion of their round.

SUPPLEMENTAL RULES OF PLAY

OUT OF BOUNDS: Defined by the nearest inside edge at ground level of white stakes, white lines, boundary fences, metal guard rails and public road ways.

- A. The Driving Range to the right of #18 is out of bounds.
- B. A ball which crosses a public road defined as out of bounds is out of bounds even though it may lay on another part of the golf course.

ABNORMAL COURSE CONDITIONS: See Rule 16.1c

Enclosed white-lined areas are defined as ground under repair, see Rule 16. French drains are deemed to be ground under repair.

BUNKERS: For a ball that lies in a bunker, the player may lift, clean and place – 1 club length no closer to the hole or play the ball as it lies. If lifted, the ball must remain in the bunker. Players may NOT improve the sand in the area of intended placement. Players should smooth their damage in a bunker as much as possible after play from a bunker. Bunker rakes may be removed from the course.

IMMOVABLE OBSTRUCTIONS: Paved, stone and dirt cart paths are immovable obstructions and relief may be taken in accordance with Rule 16.1a. Wood chipped and GUR areas leading into cart paths will have the same status as the path, that of obstructions.

- A. Gravel, mulched, or damaged turf leading into a cart path are to be considered part of the obstruction.
- B. Rock pilings and railroad ties located in penalty areas are to be considered integral parts of the course.
- C. All stone walls are integral parts of the course


PENALTY AREAS: When marked with stakes and lines, stakes identify and lines define the penalty area. Artificial walls and pilings located in penalty areas are integral parts of golf course.

A. During play of hole #12, for a ball lost in the penalty area, players may use the drop zone under penalty of one stroke.

PACE OF PLAY: 2-Point checkpoint policy in effect. Time allowed to complete stipulated round at Huntsville Golf Club is **3 Hours and 45 Minutes.** Checkpoints will be on holes 9 and 18.
