NOTICE TO PLAYERS

THE RULES OF THE UNITED STATES GOLF ASSOCIATION GOVERN PLAY: Complete text of Rules and Local Rules may be found in the Official Guide to the Rules of Golf, effective January 2019. This information also supplements the 2020 PGA Local Rules (Hard Card) and the PGA Covid-19 Procedures.

FORMAT: 54-holes of stroke play for the Amateur Championship Division (scheduled for August 3-5, 18 holes each day). 36-holes of stroke play for the Middle-Amateur, Senior and Super-Senior Divisions (scheduled for August 3-4, 18 holes each day).

Amateurs – Blue Tee | **Mid-Amateurs** – White Tee | **Seniors** – Green Tee | **Super-Senior** – Red Tee

CARTS/CADDIES: Automotive transportation is permitted for this event. Players may also walk and carry or bring their own caddie. Pull carts are permitted.

SCORECARDS: Physical scorecards will not be issued and groups will be given a GGID for scoring on the Golf Genius app on the starting tee. Players should verify their scores at the scoring area at the completion of their round. 1st day score will determine 2nd day starting times.

PLAYOFF: Sudden-death playoff for first place in any division will begin immediately following the conclusion of play. All other ties will be broken by matching scorecards in accordance with USGA guidelines.

WEATHER: Should weather delay play beyond the last day scheduled, the competition will not be extended.

PLAYERS LUNCH: Lunch will be provided on the patio (included in entry fee) for all players from 11-3 p.m.

SUPPLEMENTAL RULES OF PLAY

OUT OF BOUNDS: Defined by white stakes, white lines, stacked rock boundary walls, and split rail boundary fencing.

*The driving range and short game area is part of the General Area. Practice putting and chipping greens are wrong putting greens.

**The Pool area and Tennis Courts are Out of Bounds defined by the fencing. The fences are not obstructions.

***The Parking Lot is Out of Bounds defined either by stakes or the outside edge of parking lot pavement.

ABNORMAL COURSE CONDITIONS: Enclosed white-lined areas are defined as ground under repair, see Rule 16.

*Flowerbeds (mulched and prepared) are considered No Play Zones and relief is Mandatory.

**Trees with wire netting closely attached are NOT ground under repair, whether or not they are mulched.

FLAGSTICKS: Players are not permitted to touch the flagsticks.

BUNKERS: For a ball that lies in a bunker, the player may lift, clean and place – 1 club length no closer to the hole or play the ball as it lies. If lifted, the ball must remain in the bunker. Players may NOT improve the sand in the area of intended placement. Players should smooth their damage in a bunker as much as possible after play from a bunker. Bunker rakes may be removed from the course.

IMMOVABLE OBSTRUCTIONS: Paved cart paths are immovable obstructions and relief may be taken in accordance with the Rules. Wood chipped and GUR areas leading into cart paths will have the same status as the path, that of obstructions. Stones that have 'broken away or fallen off' from stacked rock boundary walls are movable obstructions.

PENALTY AREAS: When marked with stakes and lines, stakes identify and lines define the penalty area. Artificial walls and pilings located in penalty areas are integral parts of golf course.

PACE OF PLAY: 2-Point checkpoint policy in effect. Time allowed to complete stipulated round at Lebanon Country Club is **3 Hours and 45 Minutes**. Checkpoints will be on holes 9 and 18.
